**03-mahr (gift / dowry)**

both the bride and the bridegroom, should agree upon something as mahr. mahr is a gift that is necessary (wajib) to be paid by the groom to the bride. mahr can be anything that has a benefit and a market value such as money, gold, book, flower, taking the bride for hajj, ziyarat, even labor such as teaching quraan etc. mahr can be prompt, paid at the time of marriage, or deferred, paid later upon request of the bride. in the second case (deferred mahr), the bride can ask for the mahr at any time after the marriage.

**04-sharaait (conditions)**

bride and bridegroom can agree upon a condition(s) at the time of marriage, otherwise the marriage will be absolute (mutlaq), and without any condition (unconditional). in the case of putting some conditions, such condition(s) become necessary (binding), and therefore should be fulfilled.

(please note that these conditions are to protect the women, the men and their family from the threatening moral chaos and vacuum-of-the-values disastrous situations in the non-Divine culture and society, which some have fallen prey of, causing a bad name for islam, damaging the great unsurpassable value-system of islamic morality before others in the society, and causing injustice for men, women or children. islam stands for justice for all, meaning no husband has the right to oppress the wife and no wife has the right to oppress the husband, and they both don't have the right to oppress the children. once any mubah (islamically permissible) condition is agreed upon by both the parties, it is applicable and binding for both.)

**husband is giving his wife irrevocable wikalat of talaq (making her an agent to recite talaq) on his behalf and husband makes his wife irrevocable wakeel fit-tawkeel (right to appoint an aalim as a wakeel on her behalf to recite her talaq) in all the following situations:**

1. absolutely (in a mutlaq way)
